Also since no BIS Lab has SOLAS Accredited status it may be presumed that BIS Standard may not follow SOLAS Standards as per requirement of the tender. Summarily the Life Jacket or Life Buoy manufacturer should have Indian Registrar of Shipping Approval to satisfactorily supply these products.

Further the TYPE approval from IRS is based on specified design and drawing duly approved by IRS and no minimum changes can be done to accommodate the product as per specification which will violate the approval. Technical Specification	Crotch Strap to keep life jacket in place in safe and correct position	As per IRS/SOLAS Standard there is no mention of Crotch Strap and we request you to kindly omit this clause also. Since no design change is possible from IRS approved design inclusion of Crotch Strap is requested to be eliminated. Also there is no mandate in the standard (SOLAS / IRS) for Crotch Strap and the component seems to be a Brand Specific inclusion manufactured by some Limited Brands only. Further more our practical observation on including a Crotch Strap in a life Jacket has a very serious impact, as in the event the victim or rescuer has to jump in water from a height (ex 6 mtrs) the	Please Refer Corrigendum-I

destinate				Crotch strap will hit the GROIN Area (Specially for Males) with a high impact due to the water pressure developed. This might prove very serious or even fatal post jumping from height. Since the product under procurement is Life Saving equipment it is requested to omit this component from the specification.	•
