Section VII/3- Technical Specifications /XIII (a)	It has been our experience in supplying many boats to the Indian Navy, that a foam filled collar is more beneficial than a conventional air-filled collar in terms of leakages. It is requested that same should be changed to foam filled collar.	As per RFB Document
