2. Government of Assam has applied for financing from the International Bank for Reconstruction and Development (IBRD) in the form of a loan toward the cost of Assam Inland Water Transport Project. The Assam Inland Water Transport Project and intends to apply part of the proceeds of this credit to eligible payments under the contract for which this invitation for quotations is issued.
3. **Bid Price**
 - a) Corrections, if any, shall be made by crossing out, initialing, dating and re-writing.
 - b) All duties, taxes and other levies payable on the raw materials and components shall be included in the total price.
 - c) GST in connection with the sale shall be shown separately.
 - d) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
 - e) The Prices shall be quoted in Indian Rupees only.
 - f) The format for Bid Price is enclosed as Annexure II.
4. Each bidder shall submit only one quotation. Bidder shall not contact other Bidders in matters relating to this Quotation.
5. Self-certified photocopies of Trade License, PAN Card, GST Registration and Bank Details (Cancelled Cheque) need to be submitted along with the bid failing which the quotation will be rejected.
6. **Validity of Quotation**
Quotation shall remain valid for a period not less than 60 days after the deadline date specified for submission for evaluation.
7. **Evaluation of Quotations**
The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which

- (a) are properly signed; and
- (b) conform to the terms and conditions and specifications.

The Quotations would be evaluated for all the items together excluding of GST.

8. Award of contract

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- 8.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- 8.2 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order.
- 9. The rates/ price quoted should be valid for at least 180 days and delivery will be taken as per requirement of AIWTD society.
- 10. Payment shall be made after delivery of the goods (subject to availability of funds).
- 11. Normal commercial warranty/guarantee (12 months or more) shall be applicable to the supplied goods. The AMC charges (labour only) shall not be more than 20% of the prices quoted for each item if the customer desires to undergo AMC contract.
